The Birdies for Charity Bonus Fund continues the bonus promise.

The Birdies for Charity Bonus Fund was established to support the continuing efforts of the John Deere Classic, a 501(c)(3) not-for-profit organization, to provide bonus dollars to participating organizations.

The tournament will guarantee a 5% bonus to all charities, on amounts up to their prior year pledge total, or \$100,000, whichever is greater. Additional bonus dollars are based on the amount raised through the Bonus Fund. This fund is supported with tournament revenues, support from corporations, direct donations, special events and a generous matching grant from John Deere. These dollars are distributed annually, and are not designed to compete with, but to enhance the benefits for the hundreds of charities that participate in the program.
